
# 2024 Junior Parent Handbook









2024 is SOPA's 18th anniversary of offering dance + circus education to Springfield. This Registration Booklet is designed to help you organise your family. Put the dates into your family calendar and be well-planned for 2024.



### Why is SOPA different?

The Studio of Performing Arts (SOPA) was created by Founder Danielle Lennon when her youngest child was 4 years of age. Struggling with speech-delay and hearing loss it was recommended that little Zoe, start dance or gymnastic lessons to help with her balance and social skills.

Danielle researched and attended local dance schools, in many cases, young un-trained dance students were teaching children. As a qualified schoolteacher this wasn't a solution. In 2006, with the support of Logan City Council, Greenbank Studio of Performing Arts was started at Greenbank community centre, one day a week with just 7 children.

### Fast-forward to 2024

SOPA is the only dance school in Australia that is also a registered provider of school aged care through their incredibly popular SOPA-OSHC.

All teachers are qualified in Dance, Gymnastics, Circus or Acrobatics + are trained educators within childcare...which means they really know their stuff and understand how to guide your child.

With a Master of Education: Guidance & Counselling, Danielle & the SOPA team all have personal interests in neurodiversity. Through daily meetings and quarterly training sessions staff discuss best practice to support both mental and physical health of the children & teens in their care.

### **SOPA Junior Program**

With three distinct programs at SOPA, the Junior Program is dedicated to students from school Grade 1 to Grade 3 ONLY. It builds on the joy of dance developed in the Tiny Tots Program, children now participate in a 4<sup>th</sup> class per week by joining the very popular Musical Theatre class. Children learns acting and drama skills combined with dance and vocal skills.

Children's classes in Grade 2 and Grade 3 also increase in duration, moving to 45 minutes to prepare students for more intricate skills in SOPA's Intermediate Program. The SOPA Jnr Program develops social skills, building child self-efficacy and self-belief.

### Why the SOPA team matters to your family...

SOPA students reach their personal potential because of the consistency of the SOPA Team. SOPA focuses on positive relationships, between management, educators and students.

Extra-curricular activity is an identified protective layer for positive mental health. Older SOPA students often ask to speak privately to SOPA Founder Danielle Lennon or can be found sitting and talking with Reception staff. Having a connected community of adults who care about your child, begins when they are small and is proven to aid in positive developmental growth.

Key staff are critical to developing these positive relationships. At SOPA you won't see teachers changing, in fact most SOPA staff have also been SOPA students and then go onto work for the company. This means that your child and their 'normal' behaviour and emotions are known by us. SOPA teachers routinely report concerns to their Leadership Team. These key relationships allow for easier communication with parents and better support for all students within our care.

Nurturing the relationships between educators, staff, students, and families is core to SOPA beliefs of family and community. SOPA educators and staff openly share their knowledge and experience with families through Term lessons, casual conversations as well as in Before School Care, After School Care and Vacation Care.

SOPA's multi-tiered approach to dance + circus education means that families always have 'go to' staff member to ask questions of or raise concerns with. Similarly for your children, they have key educators that they know and trust, this aids their agency and ability to talk up about concerns or accomplishments whether they be at SOPA, school or home. At SOPA we are crazy about your kids!

Enrolments are open year-round. If you are joining mid-term your account will be pro-rata.

We recommend you try as many different classes as possible and see which style you want to commit more time to. Once you decide to join us your \$20.00 will be credited off your first term invoice. (So really it is a FREE TRIAL)

Our Money Back Guarantee assists students and parents to completely settle into The SOPA Lifestyle. We believe that you should be happy with our care and service; after completing your first four weeks, if you are not happy, we will refund the balance of your term fees.

- Refunds are calculated on the remaining weeks of the term.
- We are unable to offer refunds for withdrawals before the 4<sup>th</sup> week of enrolment.
- Registration fees are non-refundable.

### **Accolade Week**

Accolade Week recognises the hard work students have put in all year during class. All students currently in Term 4 (incl. those who did not participate in the Annual Concert) receive a personally engraved medal & a certificate in Week 7. We encourage students to also thank their teachers and staff during this time. Perhaps with a card or a picture they have drawn.

### **PICK-UP Procedure**

To minimise congestion in Reception, students will be released onto the balcony where you will be waiting. If you are running late, pop through a text to Reception and your child will wait with their teacher in their last class. Alternatively, you are welcome to stand on the hill provided you are clearly visible.

For the final classes of the evening, parents must meet the teachers outside our bottom door. For Staff & Student Safety, the balcony is locked after 8pm, therefore visibility is greatly reduced.

Hear the squeals of delight as your child begins to recognise their strength and coordination. Watch as they dance in the aisles, tumble in your lounge room, and act up a storm. Students have longer lessons in our Junior Program developing their focus and technique. The annual Junior Concert is designed just for them. Grade 3 students are always excited for their on-stage graduation into the Intermediate School.

Concert Costumes: Maximum of 2 Costumes if participating in all classes Costumes are capped at a maximum of \$100.00 each.

### **DEPOSITS**

A \$60 deposit per costume is due on the 20<sup>th</sup> July 2024. The Junior Concert is a non-compulsory event. As deadlines for costume manufactures and delivery timelines exist, deposits cannot be accepted after the 20<sup>th</sup> July 2024.

### **HOW CAN I REDUCE MY CONCERT COSTS?**

Budget throughout the year, consider not buying the DVD (maybe a relative would buy it as a gift for your child).

Bring in NAMED Costume Bag WITH a coat hanger by the 20<sup>th</sup> July, so you are not charged for a new bag.

### **Cover-Ups**

To protect our dancers from outside debris, students are not allowed to wear dance shoes to and from classes.

Students are required to change their shoes in the hallway before entering class. Teachers will ask students to change into their outside shoes before leaving. It is crucial that students bring a change of shoes to classes as they cannot leave barefoot or in dance shoes.

It is also important to remember that the air conditioning can be quite cool at the beginning of lessons. We recommend the purchase of our SOPA zip jacket.

### **ATOD Examinations**



Would your child like the challenge of participating in exams?

### What happens

The week before Exam Day, children participate in small group lessons at SOPA during the week of their exam. They consolidate their class work and practice doing their skills facing the examiner and demonstrating when asked.

On Exam Day, students arrive 45 minutes before their scheduled examination, they relax and warm-up with their teachers and enter Studio 1 with their Nationally Accredited Examiner.

After Exam Day students receive a Medal, Certificate and Report. During Accolade Week in Term 4 students are presented with a trophy for sitting their exam. Exams help develop confidence, resilience and technique and provide QCE points for students in Grade 11 & 12.

# WHAT IS SOPA-OSHC?

SOPA-OSHC as we like to call it is. The Studio of Performing Arts and it is Australia's only Approved Provider of Outside School Hours Care that is within a Circus + Dance school.

Danielle has completed a Masters: Guidance & Counselling with a special focus on increasing Physical Activity in children through opportunities for Risky Play. SOPA-OSHC children enjoy these dedicated times each day, where they are encouraged to assess risk and make a choice; deciding if they would liked to 'give-it-a-go", change the game or sit out and observe. These opportunities for Risky Play are research based and are shown to improve children's voice and their self-efficacy.

The SOPA-OSHC team are professional teachers in the Arts + passionate educators.

From juggling to Aerial Lyra, to acting and dance, SOPA-OSHC children are active and creative everyday!

### What happens in ASC

At After School Care (ASC) children arrive at SOPA and have Active Play to re-connect with friends from the .six schools that SOPA services. We then join together for Yarning Circle and a healthy Afternoon Tea before we start our Circus Kids Incursion. Homework Hub is also available, as well as loose parts play and Art.

### What happens in BSC

At Before School Care (BSC)
healthy breakfast options are
offered. Children play with Big
Blocks; building forts, towers, and
boats or design a rollercoaster with
small loose parts play. Children may
need a quieter option of chilling by
watching a favourite movie, or
learning new board or card games.
At 8.10am we prepare for school.

### What happens in VC?

Children in Vacation Care (VC)
engage in Creative Play with the Big
Blocks until Yarning Circle. We head
on excursion to Robelle Domain for
90 minutes of Active Play. When we
return children are divided into two
groups for their 90 minute Circus
Incursion and Art or Slime-Making.
Quiet Time occurs in the afternoon
before parent pick-up.

### The Studio of Performing Arts

### Terms, Conditions & Waiver

As a customer of The Studio of Performing Arts ('Service Provider') these terms, conditions and waiver form the basis of your agreement with the Service Provider. Agreements with you include your registration form, which you complete and provide to Service Provider.



### 1. Money Back Guarantee

1.1 If your child participates in 4 weeks of classes and is unsatisfied, you must notify the Service Provider in writing and remaining term fees will be refunded on a pro-rata basis.

### 2. Refunds, Discounts and Credits

- 2.1 Annual Registration fees are non refundable.
- 2.2 Uniform costs are non refundable

No refunds, discounts or credits are given for missed classes. The exception being for long term illness, 2 weeks written notice period will remain and fees will be refunded on a pro rata basis. If you miss a class and notify the Service Provider in writing before the class commencement, alternative make-up classes (subject to availability) can be arranged and attended within the same term as the absence. Maximum of 2 make-up classes per term.

2.3 If government regulated lockdown isolation is required, the timetable will go online. Hybrid lessons can be arranged if needing to ZOOM (or similar) into face-to-face classes.

### 3. Costs

3.1 Fees will be paid by the due date of each term

If you require a Payment Plan contact the Service Provider Business Manager. A 10% administration fee will be added to accounts that are not paid by the due date.

3.2 Students are invited to participate in exams, performance teams & annual concerts, all incur additional charges including but not limited to; exam /test fees, formal uniform purchase, extra rehearsal fees, costume purchase/hire, concert ticket purchase. The Service Provider provides information to enable you to make informed decisions as to whether to participate.

3.3 The Service Provider reserves the right to cancel or change the timetable and price structure at any point in time.

### 4. Recreational Activity Risk Warning, Acknowledgement, Waiver and Release

  - Torn muscles, fractures, twisted ankles etc.
- 4.2 Before your child participates in the Recreational Activities, you should ensure that you are aware of, and properly understand, all of the risks involved in the Recreational Activities, and that those risks will include any particular risks associated with any health condition or pre-existing disability from which your child suffers.
- 4.3 By signing this document, you acknowledge, agree and understand that your child engages or participates in the Recreational Activities voluntarily and at their own risk in full knowledge of the Risks generally and Particular risks described above.
- 4.4 If signing this document as a parent, guardian or responsible person performing parenting responsibilities, you acknowledge and agree that you have explained to the participant that the Recreational Activities provided by the Service Provider may involve risks generally; and the Particular risks described above.
- 4.5 By signing this document, you also acknowledge, agree and understand that the risk warning above constitutes a formal 'risk warning' for the purposes of therelevant legislation, including for the purpose of Sections13 19 of the Civil Liability Act 2003 (QLD).

  - physical or mental injury (including the aggravation, acceleration orrecurrence of such an injury);
  - the contraction, aggravation or acceleration of a disease;
  - the coming into existence, the aggravation, acceleration or recurrence of any other condition, circumstance, occurrence, activity, form of behaviour, course of conduct or state of affairs:
    - o that is or may be harmful or disadvantageous to you or the community;
    - o that may result in harm or disadvantage to you or the community;
    - that may be suffered by you (or a person for whom or on whose behalf you are acquiring the services) resulting from the supply of recreational services or recreational activities is excluded.

Even if you sign this document, you may still have further legal rights.
- 4.12 By signing this document you agree that the waivers and releases contained inthis document apply for every visit you make to the Service Provider until such time as you withdraw or modify your consent in writing or the Service Provider modifies these terms with your consent by signing a new document. You will not be required to sign future waivers on the understanding that this waiver document shall apply to all future participation in the Recreational Activities.
