# Welcome to SOPA's 2025 Senior Parent Handbook for SOPA Senior School

Celebrating our 19th anniversary, The Studio of Performing Arts (SOPA) is here to support your family with a dedicated program designed to help pre-teens and teens thrive. This Handbook will help you stay organised for the year ahead—mark those important dates and get ready for an enriching 2025.

#### Why is SOPA different?

SOPA was founded by Danielle Lennon, a qualified high school teacher with a Master of Education in Guidance and Counselling. The inspiration began when Danielle's youngest child, Zoe, faced early developmental challenges. Seeking a supportive, high-quality program for her, Danielle realized the need for professional, nurturing education in the performing arts. With support from the Logan City Council, SOPA began in 2006 with just seven children at the Greenbank Community Centre and has since grown into an essential part of the Springfield community.

Today, SOPA stands as Australia's only dance school registered as a school-aged childcare provider through our SOPA-OSHC program. All teachers at SOPA hold qualifications in Dance, Gymnastics, Circus, or Acrobatics and are trained in childcare. Danielle's background includes creating the dance program at The Springfield Anglican College and over five years of teaching experience at the Primary School level. With this strong foundation, SOPA has developed a team guided by daily meetings and quarterly training focused on best practices to support the mental and physical health of children and teens.

The SOPA team is led by Danielle and Zoe Lennon, the little girl who inspired SOPA's creation and is now our Dance + Circus Coordinator. Zoe, in the final stages of completing her degree in high school teaching and already a qualified dance teacher, brings a fresh and passionate approach to the program. She ensures SOPA integrates the latest insights from attachment theory and neurodiversity, creating a space where every child feels safe, valued, + encouraged to grow.

#### **SOPA Senior Program**

Our Senior Program is designed to support pre-teens and teens when they need it most, providing a range of classes that cater to their mental and physical health, as well as their growing interests. From Grade 4 onward, students in the Senior Program have access to our full menu of classes, including Aerial Lyra, Contemporary Dance, and more. The hardest decision is choosing where to begin!

Through this program, teens build their personal, cognitive, and physical skills, allowing them to experience a sense of accomplishment every year. We know that upper primary and high school brings new demands—from homework to social pressures—which is why SOPA has created a supportive community that serves as an extension of your family. Here, students have a network of caring adults who know them well, celebrate their victories, and help identify any concerns along the way.

SOPA becomes a second family for your pre-teen and teen, offering a safe, supportive environment where they can truly be themselves.



#### Why the SOPA Team Matters to Your Family

At SOPA, we understand that consistency and support from a dedicated team help students reach their personal potential. Our focus on strong, positive relationships between management, educators, and students creates a unique environment where teens feel safe, supported, and valued.

Extra-curricular activities play a significant role in promoting mental health, especially during the pre-teen and teen years. SOPA offers a welcoming space where students can seek out trusted adults for guidance. SOPA students often connect with Director Danielle Lennon or chat with Reception staff, knowing they have a community that genuinely cares. This network of supportive adults is proven to aid in positive developmental growth.

SOPA key staff are integral to these relationships. SOPA has a highly consistent highly qualified team; there is no other dance school in Australia who has a Guidance Counsellor as it's Founder. Most of our teachers have been SOPA students themselves and continue on as educators, building on the SOPA community from within. This continuity means our staff know your child well, understand their "normal" behaviours, and are quick to recognise any changes or concerns. SOPA teachers routinely communicate these observations to the Leadership Team, ensuring thorough support and open communication with families.

Nurturing connections between educators, students, and families is central to SOPA's commitment to family and community. Our educators and staff regularly share insights and experiences through term lessons, casual conversations, and even during Before School Care, After School Care, and Vacation Care programs.

SOPA's multi-tiered approach to Dance + Circus education gives families a reliable "go-to" staff member for any questions or concerns. For pre-teens and teens, these consistent, trusted relationships provide a safe foundation for them to express their challenges and accomplishments, both at SOPA and beyond. #### **Lesson Prices**

At SOPA, we provide discounts based on the number of classes in which each family is enrolled. Whether one child is taking multiple classes or multiple children from the same household are enrolled, our pricing structure is designed to make participation more affordable as the number of classes increases.

This discount also is you are enrolled in extra holiday or exam lessons. It includes any extra lessons your child may take, except Private Lessons. Discounts apply based on the total number of classes enrolled during the term / program. This approach ensures that families benefit from the most cost-effective option as they invest in their child's dance + circus education.

We recommend budgeting for a 10-week term, although some terms may be more or less than 10 weeks based on the State School Calendar and Public Holidays

**Enrolment** Enrolments remain open throughout the year, based on class availability. If you join mid-term, your account will reflect a pro-rata adjustment.



**\$20.00 7-Day Trial Pass & Money-Back Guarantee** Young children need time to adjust to new environments. To ease this transition, we offer a \$20.00 7-Day Trial Pass, backed by a Money-Back Guarantee.

Our \$20.00 7-Day Trial Pass allows your family to experience our classes and community. With many options available, we suggest trying different classes to find the best fit. If you decide to join us, we will apply your \$20.00 to your first term invoice.

Our Money-Back Guarantee supports both children and parents in settling into the SOPA lifestyle. After completing four weeks, if you feel our program does not suit, we will refund the balance of your term fees.

- Refunds apply to the remaining weeks of the term.
- Withdrawals before the fourth week are not eligible for refunds.
- Registration fees remain non-refundable.

**Accolade Week** Accolade Week celebrates the dedication and effort children show all year. All children enrolled in Term 4, including those not in Annual Concert, receive a personalised medal and certificate in Week 7. Children may choose to express gratitude to their teachers, possibly with a card or a drawing.

Note: We do not charge additional fees for Eisteddfod participation, insurance, medals, or trophies.

**Drop-Off Procedure** On weekends and after 6 p.m., a student waiting room is available, with bathrooms, a kitchenette, and a study nook.

**Pick-Up Procedure** To reduce congestion in Reception, children meet parents on the balcony. If you expect a delay, send a quick text to Reception; your child will wait with their teacher in the last classroom. Parents may also wait on the hill where teachers can see you.

For final classes of the evening, parents should meet teachers outside the bottom door. For safety reasons, we lock the balcony after 8 p.m., limiting visibiliy



# **SOPA Senior School Requirements:**A Guide to Dance + Circus Opportunities

This guide helps you understand the requirements and expectations for each specialised lesson, so your child can fully benefit from SOPA's programs.

#### **Classical Ballet**

• Requirement: Students must attend two ballet lessons per week if they wish to enrol in Classical Ballet.

#### **Contemporary Dance**

• Requirement: Students must either attend two ballet classes per week or one Jazz class per week to enrol in Contemporary Dance.

#### **Performance Teams - Dance**

- Overview: These teams provide additional performance opportunities for students. Available teams are 12 years & Under or Open Performance Teams, students must join by January 17 each year.
- **Genres Covered:** Students learn **six dances** each year in Contemporary, Jazz, and Hip Hop, performing at:
  - Two Ipswich Eisteddfods
  - Mid-Year Showcase (Term 2)
  - SOPA Annual Concert Series (with Junior and Senior performances)
- Costumes: Students need three extra costumes each year (one per genre), which are used at all five performances.
- Eligibility Criteria:
  - o 12 years and Under or Opens Teams Must be enrolled in:
  - 1. Ballet PLUS either Jazz or Contemporary, OR
  - 2. BOTH Jazz + Contemporary.

#### **Performance Team - Lyra (Aerial)**

- Overview: This team provides additional Lyra (aerial hoop) performance opportunities.
   Students must join by January 27th each year. Elite Lyra students may compete in State and National Bend The Air Competitions and will perform a special routine at the Concert.
- **Solo Choreography:** Each student in the Lyra Performance Team receives a solo piece created specifically for them.
- **Costume:** One extra costume per year is required. This costume is selected and hired through SOPA. Personal costumes are allowed if approved by SOPA, and they are used at all competitions and performances.
- Eligibility Criteria: Students must be enrolled in:
  - 1. Base Aerial Lyra Class
  - 2. One Technique Dance Class (Jazz, Contemporary, or Ballet ONLY)
  - 3. Elite Lyra Class

#### **Benefits of the Senior Concert**

The Annual Senior Concert offers students the chance to showcase their growth in skill, artistry, and performance techniques in a professional stage environment. Performing onstage not only strengthens technique and confidence but also builds teamwork, resilience, and dedication. Students gain invaluable experience performing in front of an audience, which enhances their confidence and joy in sharing their hard work.

#### **Concert Costume and Deposit Details**

- **Costume Details**: Each enrolled style of dance or circus class requires a costume, with a maximum cost of \$120 per costume.
- **Deposit**: A \$65 deposit per costume is due by Saturday, August 2, 2025. This deposit will be deducted from the final costume invoice. Please note, deposits are non-refundable after this date due to manufacturing timelines.
- Location: The concert will take place at St John's Anglican College Theatre in Forest Lake.

#### **Keeping Costs Manageable**

To help manage concert expenses:

- Plan a budget throughout the year.
- Consider having a family member purchase the concert DVD as a gift.
- Bring a labeled costume bag with a coat hanger by August 2, 2025, to avoid additional charges.

#### **Additional Support for Families**

- **Free Makeup and Hair Workshop**: Offered in Term 4, this workshop guides students on concert-ready makeup and hair.
- Makeup: Optional for the concert.
- **Videos for Practice**: Videos are published in BAND groups for students who may miss rehearsals or want extra practice.

This concert experience serves as an incredible milestone for Senior students to celebrate their hard work, build performance confidence, and enjoy the camaraderie of a shared community accomplishment on stage.



#### **Uniforms**

Uniforms are a compulsory part of the learning environment at SOPA. Our uniform requirements are designed with flexibility, offering a range of options to suit the needs and comfort of all students.

Uniforms help create a sense of unity and professionalism, encouraging focus and pride in each student's role as part of SOPA. All uniform pieces can be purchased directly from our Reception.

#### **Cover-Ups for Your Child's Safety**

To keep our dance spaces clean and safe, here's what to keep in mind:

- **Changing Shoes**: For safety, children should change into their dance shoes in the hallway before entering class. At the end of class, teachers will remind them to change back into outside shoes. Please ensure your child has a pair of outside shoes to wear when arriving and leaving, as going barefoot or wearing dance shoes outside is not allowed.
- Stay Warm + Safe travel between SOPA and Parents: The air conditioning can feel quite cool at the beginning of lessons. We are also on Level 1 of a mixed complex. It is important for children to understand the need to keep muscles warm after class. We recommend purchasing a SOPA Jersey or SOPA Jacket to keep your child comfortable.

#### **ATOD Examinations**

Is your child ready for a new challenge in dance? SOPA offers the opportunity to participate in **Nationally Accredited Dance Examinations** with the **Australian Teachers of Dancing (ATOD)**, a wonderful way for young dancers to gain experience, confidence, and recognition. **Examinations** are held each year in the **July School Holidays**, making it easy to plan.

#### What to Expect

#### Pre-Exam Week

The week before Exam Day, children join small group practice sessions at SOPA, refining their skills and preparing to present them with confidence. They will practice facing an examiner, learn to demonstrate techniques when asked, and build comfort with the process.

#### **Exam Day**

Students arrive 45 minutes before their scheduled examination, where they warm up and relax with their teachers. They will then enter Studio 1 with their Nationally Accredited Examiner, who provides a supportive environment for each student to perform their best.

#### **Post-Exam Recognition:**

After Exam Day, students receive a medal, certificate, and report to celebrate their hard work. During **Accolade Week** in Term 4, students are presented with a trophy in honor of their achievements. Exams help develop essential skills in **confidence**, **resilience**, **and technique**, and even contribute **QCE points** for Grade 11 and 12 students in the future.

Participating in ATOD exams not only advances your child's dance abilities but also provides them with a sense of accomplishment and growth that extends well beyond the studio.

#### Terms, Conditions & Waiver

As a customer of The Studio of Performing Arts ('Service Provider') these terms, conditions and waiver form the basis of your agreement with the Service Provider. Agreements with you include your registration form, which you complete and provide to Service Provider.

#### 1. Money Back Guarantee

1.1 If your child participates in 4 weeks of classes and is unsatisfied, you must notify the Service Provider in writing and remaining term fees will be refunded on a pro-rata basis.

#### 2. Refunds, Discounts and Credits

- 2.1 Annual Registration fees are non refundable.
- 2.2 Uniform costs are non refundable

No refunds, discounts or credits are given for missed classes. The exception being for long term illness, 2 weeks written notice period will remain and fees will be refunded on a pro rata basis. If you miss a class and notify the Service Provider in writing before the class commencement, alternative make-up classes (subject to availability) can be arranged and attended within the same term as the absence. Maximum of 2 make-up classes per term.

2.3 If government regulated lockdown isolation is required, the timetable will go online. Hybrid lessons can be arranged if needing to ZOOM (or similar) into face-to-face classes.

#### 3. Costs

3.1 Fees will be paid by the due date of each term

If you require a Payment Plan contact the Service Provider Business Manager. A 10% administration fee will be added to accounts that are not paid by the due date.

3.2 Students are invited to participate in exams, performance teams & annual concerts, all incur additional charges including but not limited to; exam /test fees, formal uniform purchase, extra rehearsal fees, costume purchase/hire, concert ticket purchase. The Service Provider provides information to enable you to make informed decisions as to whether to participate.

3.3 The Service Provider reserves the right to cancel or change the timetable and price structure at any point in time.

#### 4. Recreational Activity Risk Warning, Acknowledgement, Waiver and Release

- 4.1 Participation in Circus, Acrobatics, Dance and Drama Lessons ('the Recreational Activities') supplied by the Service Provider involves significant risks, including the risk of property damage and personal injury. Particular risks include, but are not limited to:
  - Torn muscles, fractures, twisted ankles etc.
- 4.2 Before your child participates in the Recreational Activities, you should ensure that you are aware of, and properly understand, all of the risks involved in the Recreational Activities, and that those risks will include any particular risks associated with any health condition or pre-existing disability from which your child suffers.
- 4.3 By signing this document, you acknowledge, agree and understand that your child engages or participates in the Recreational Activities voluntarily and at their own risk in full knowledge of the Risks generally and Particular risks described above.
- 4.4 If signing this document as a parent, guardian or responsible person performing parenting responsibilities, you acknowledge and agree that you have explained to the participant that the Recreational Activities provided by the Service Provider may involve risks generally; and the Particular risks described above.
- 4.5 By signing this document, you also acknowledge, agree and understand that the risk warning above constitutes a formal 'risk warning' for the purposes of the relevant legislation, including for the purpose of Sections13 19 of the Civil Liability Act 2003 (QLD).
- 4.6 Section 139A of Competition and Consumer Act, 2010 (Cth) permits the Service Provider of the Recreational Activities and associated services to ask you to agree that the statutory guarantees under the Australian Consumer Law (Cth) do not apply to you (or a person for whom or on whose behalf you are acquiring the services to engage in the Recreational Activities).
- 4.7 By signing this document, you acknowledge, agree and understand that, to the full extent permitted by law (including section 139A of the Competition and Consumer Act 2010 (Cth)):
  - Your rights (or the rights of a person for whom or on whose behalf you are acquiring the services) to sue the Service

    services were not provided to you in accordance with any express or implied warranty or guarantee that the services will

#### 5. Class Procedure

- The Service Provider requests that small children are taken to the toilet before their class commences to avoid disruption to class.
- The Service Provider classes/locations are nut and banana free zones.
- Arrive on time and ensure your child is collected on time.
- To maintain a positive teaching environment, classes are closed to visitors unless otherwise scheduled with Reception.
- Mobile phones are to be switched off and in bags
- No outside shoes are permitted inside SOPA rooms, these must be removed and replaced by dance shoes before entering.

#### 6. Communications
